
Attached for your review and comment is my March 15, 2001, motion to the court in my current civil action LAMBROS vs. FAULKNER, et al., Civil No. 98-1621 (DSD/JOM). (CLAIM EIGHTEEN (18))

PLEASE NOTE that you represented me in U.S. vs. LAMBROS, Criminal No. Cr. 3-76-17 as to my PLEA in that action. My research indicates that the INDICTMENT is not valid as the court did not have subject matter jurisdiction to a alleged assault that occurred on property not owned by the U.S. Government. Both Courts I and II contained violations of Title 18 U.S.C. Section 114, "MAIMING WITHIN MARITIME AND TERRITORIAL JURISDICTION OF THE UNITED STATES."

The ten (10) years I received is still causing negative implications in my life and I'm requesting your thoughts as to some type of solution to this matter.

On March 30, 2001, I wrote you via U.S. Certified Mail - Return Receipt as to U.S. vs. LAMBROS, CR-3-76-17, in which you represented me. To date I have not received a response from you or your office.

Upon review of my U.S. Bureau of Prison's records, the records state that I plead guilty to MURDER in violation of Title 18 U.S.C. § 1114. As you know, Criminal Indictment CR-3-76-17, clearly states violations of Title 18 U.S.C. §§ 111 and 114.

Will you submit an AFFIDAVIT as to my guilty plea in Criminal Indictment CR-3-76-17, to violations of Title 18 U.S.C. §§ 111 and 114?
